# Western Nevada County Fire Facilitated Meeting on District / Citizen Concerns September 10, 2019

# When will the reorganization start?

This will go to the voters on the November ballot of 2020. If this does pass, revenue will not be seen until 2022. The BOS will not have the election certified until December 3, 2020 and the SBOE has a deadline of December 1. This is an 18-month delay in funding but gives time to get the administrative and ground work completed.

# **District Autonomy**

The discussion took place of the history of consolidation talks. Chief Tracey Hansen spoke on how Consumes was still working on being fully consolidated when she left, which was 7 years after consolidation. Change the District name so it is new and not falling under another agency name. Firefighters associations, they can remain separate or come together. Be sure to come together to send one message to communicate to your employees, the board and constituents. Careful consideration during the branding will take place to preserve historical identities of the agencies. Ideas discussed were, "Serving the Community of \_\_\_\_\_\_" on engines or still identifying on dispatch.

# Auxiliaries and other support groups status

The auxiliaries can remain, and funds will keep supporting the community and will need to be defined clearly in consolidation/reorganization discussions. Specific items purchased must be the same specifications for all equipment, such as Jaws, TICS, etc.

# Paid Call Firefighters / Volunteers

The history of the fire agencies in Nevada County is once they have become career staff the volunteers dissolved. Relationships get strained when not seen as an equal, this starts at the top. The discussion took place on the minimum requirements of volunteers. There can be tiered levels for volunteers, but you must follow the laws, that is not negotiable. You must maintain certifications and mandated training. If you do not and you have an incident you can be liable civilly and criminally. New firefighter I standards may be coming out, with less required hours and without the experience component. OSHA consults with standards and is a great free resource to review this with. The tiered option of volunteers is still out there, you can have IDLH to a volunteer that wants to help in the office.

# Special Tax / Benefit Assessment / Escalator / AB1600

The differences of the special tax and benefit assessment were reviewed. The working group and polling group will work on which would be the better option. An escalator is necessary on either, but it needs to be reasonable. AB1600 fees were also brought up in this discussion and after this has passed and completed a study will be done and one AB1600 fee will be recognized between each of the agencies in the reorganization.

### **Fixed Income**

The polling will tell a lot regarding the demographics of the areas. The funds are needed to enhance services. The Board of Directors of the new agency will make the decision on how to proceed with services, but there could be a hardship clause if a first responder fee is utilized.

# Western Nevada County Fire Facilitated Meeting on District / Citizen Concerns September 10, 2019

Unstaffed / Browning Out Stations / Strike Team Response Availability

A comprehensive district coverage plan will have to be developed by the Chief of the new District. An example Chief Hansen gave was that Galt will always have an engine, so in their district coverage plan, if the normal staffed engine must be out of the area for an incident/training etc., another engine covers. Discussion also took place on possibly a Cal Fire contract in NSJ. The priority would be District coverage prior to sending out any Overhead or Strike Teams. The Chief will create a minimum coverage plan as well. There are emergencies where a station may need to be browned out until staffing can come in and cover.

# Reduced Community Input / Governance

Discussion took place on if there is a 5-person board, some district areas may not be heard. Ideas regarding an advisory board to the board was brought out, with the concept that each agency would have a representative on the advisory board to discuss district concerns. The County GIS department is working on mapping 5 and/or 7 zones. Each agency feels that if they all had a voice, representative in the new agency it would be received better.

### **Ambulance Operations**

The concern is that Penn Valley will be pushing ambulances all over the County. The Penn Valley ambulance must stay in that area, per their exclusive operating area (eoa). The Penn Valley ambulance only has exclusivity rights in the Penn Valley area. There may be an opportunity with a reorganization to have discussions with Sierra Nevada Ambulance to place a reserve ambulance in other locations for any draw down purposes.

# Why Reorganize

Many agencies are having staffing struggles, maintaining and backfilling. The proposed new agency has the potential to add more depth of personnel in the County, which means more coverage for the constituents. This also helps the effectiveness and efficiency of governance.

### Office Locations

Discussion took place on revolving counter hours and making more items available on-line for the public to access.
